Dear Geneva Lake Conservancy Friends:

Last night the Lake Geneva City Council did not act on a first reading of an ordinance that would allow White River Holdings LLC, the owners of the Hillmoor property, to amend the Comprehensive Plan to allow them to proceed with their development plan for the property.

The GLC and many other residents spoke against the developer's plan and of the importance of this decision to the future of Lake Geneva. The Conservancy is asking the developer to work with the city and the Conservancy to protect 60 acres of the property along the White River as a natural area with hiking and biking trails and a canoe/kayak launch. The developer is currently asking that this 60-acres retain its Private Recreation land use, which would not guarantee public access.

Following the meeting, Alderman Doug Skates agreed to set up a meeting between the city, the developer and the Conservancy to determine if a plan could be worked out to guarantee public access to this 60 acres, which is supported by a survey of residents in the Lake Geneva Parks and Open Space plan.

Please contact the Lake Geneva City Council to ask them to vote "no" to the developer's proposed amendments to the Comprehensive Plan at their next meeting. We will update you prior to that meeting.
